SUPPLEMENTAL NOTICE OF PROPOSED SETTLEMENT AND HEARING

If you Were Detained at the Montgomery County Jail (“MCJ”) For at Least Two Consecutive Weeks (14 Days) From July 25, 2011 to December 31, 2018, Then Your Rights Could Be Affected By a Proposed Class Action Settlement.

Read This Notice Carefully

The United States District Court for the Northern District of New York Authorized This Notice. It Is Not From a Lawyer. You Are Not Being Sued.

- You are provided with this supplemental notice because the initial data provided to class counsel detailing the members of the class did not contain your name. Supplemental data recently obtained by class counsel contains your name, and confirms that you are a member of the class. The Court directed that you receive this Supplemental Notice. This notice is only being provided to approximately 75 individuals.
- Please carefully review the attached class notice, which details your various rights as a class member, and provides direction on how to make a claim. This class notice also provides instructions on how you can object to or exclude yourself from the settlement. PLEASE NOTE THAT THE DATES FOR YOU TO FILE A CLAIM, FILE AN OBJECTION, FILE A REQUEST FOR EXCLUSION OR FILE A REQUEST TO SPEAK TO THE COURT, AND THE DATE FOR THE FINAL SETTLEMENT APPROVAL HEARING ARE DETAILED IN THIS SUPPLEMENTAL NOTICE, not in the initial class notice.
- The Court has adjourned the final settlement approval hearing in this action until **May 7, 2021 at 10:00 AM**. This hearing will be held telephonically and the call-in information is: 877-336-1274, Access Code: 7605766, Password: 02262021.. If you wish to be heard at the final settlement approval hearing, you need to send in a notification by **April 15, 2021**. Instructions for detailing your intention to speak to the Court are stated in the class notice.
- If you wish to object to the settlement, or exclude yourself from the settlement, you must do so by **April 15, 2021**. Instructions for objecting to the settlement, or excluding yourself from the settlement, are stated in the class notice.
- Given that the final settlement approval by the Court has been delayed because of the need to send out this supplemental notice, no late claims will be considered by class counsel. You should send in your claim form as soon as possible after receipt of this notice. **Your claim form MUST be postmarked no later than April 15, 2021**. The claim form is provided at the end of the attached class notice.
